□ Nature and scope of the acceptance and transfer of vehicles

Each transfer of risk (acceptance and transfer) will be clearly documented by CarHandling. To this end, vehicle receipt and transfer protocols will be available on site, completed in full by the CarHandling employee and issued in copy to the customer (digital by e-mail on request). The original signed by the customer or the forwarding agent appointed will remain in safekeeping of CarHandling.

□ Terms of vehicle storage and logistics

Within Hall C3 at Messe München, the orders issued by the CarHandling instructors on site must be followed. The instructors can be clearly identified by the CarHandling marking on their clothing. The unauthorized moving of vehicles inside the hall without the knowledge and supervision of a CarHandling employee is prohibited. The direction of travel indicated must be obeyed when accessing the hall in a vehicle.

CarHandling GmbH gives no guarantee for the continuous guarding and monitoring of the storage area. It is not part of CarHandling remit to safeguard the vehicles. If required, the exhibitor must organize its own security service. This can be done via IAA Exhibitor Shop or the corresponding written registration of external / own security staff with Messe München GmbH

□ Declaration of confidentiality

CarHandling guarantees for the entire term of contract the conscientious fulfillment of its tasks and the professional, competent handling of the vehicle fleet stored. CarHandling GmbH guarantees that the customer's confidentiality requirements will be met at all times and that all vehicle information will always be treated in the strictest confidence. Above and beyond the scope mentioned above, CarHandling undertakes to treat all documents and results arising in the fulfillment of its remit in the strictest confidence and to only make them accessible to third parties and/or publish them subject to the customer's written consent. Moreover, CarHandling guarantees that only such employees will have access to the data processing documents as have undertaken to comply with the terms of our confidentiality agreements and the provisions of the Data Protection Act.

□ Liability disclaimer

All vehicle movements within Messe München's exhibition hall C3 are to be organized by the customer autonomously and only carried out by its employees or the service providers appointed by it. Each vehicle movement is to occur under the supervision of a CarHandling employee. Damage caused by the customer itself is subject to the customer's own insurance coverage.
